NOTIFICATION

The 25th April 2015

No. 5368—PC-ES-ES-27/2013-P.—Government have been pleased to constitute the State Level Co-ordination Committee (SLCC) under the Chairmanship of Development Commissioner-*cum*-Additional Chief Secretary, Government of Odisha to improve the overall quality of estimates of State Domestic Product (SDP) and District Domestic Product (DDP) of Odisha.

## 1. Objectives

The objectives of the SLCC are as follows :

- (i) To minimize the data gaps faced in estimation of SDP & DDP as provided by source Departments/ Offices/Agencies.
- (ii) To ensure the timeliness of availability of data
- (iii) To improve the methodological issues of data collection and compilation by source Agencies
- (iv) To strengthen the lateral co-ordination among source Departments/Agencies for supplying timely and quality data.
- (v) To identify and recommend new area of scope, coverage, indicators, etc. of items for inclusion in source Departments/Agencies.
- (vi) To improve quality of data in source Departments/Agencies.

### 3. Terms of Reference

The terms of reference for the SLCC are as follows :

- (a) To carefully examine the current methodological issues, data collection & compilation mechanism actually followed by source Offices/Agencies & DES.
- (b) To suggest appropriate modifications in the data and methodology for credible and reliable estimation of SDP & DDP and other related aggregates.
- (c) To make such other recommendations, as the SLCC deem fit for building capacity of the Statistical wing of source Offices/Agencies and Directorate of Economics and Statistics, Odisha for quality estimates of the SDP & DDP.

### 4. Rules of Business

- (a) The Committee may meet once in every six months a year
- (b) The Chairman of the Committee may also co-opt. any of the Member of the Departments and may invite other experts in the field, or can form Sub-Committee to meet the requirement, if necessary.
- (c) The secretarial assistance will be provided to the SLCC by the Directorate of Economics & Statistics, Odisha.
- (d) The expenditure for the purpose will be borne by Directorate of Economics & Statistics, Odisha.
