ORDER

The 23rd June 2015

No. 3128—Ele.(GP)-02/2015-SEC.—Whereas, Collectors and Sub-Collectors of different Districts have submitted proposals for by-elections to the offices of Zilla Parishad Members, Panchayat Samiti Members, Sarpanches and Ward Members as per Odisha Zilla Parishad Election Rules, 1994, Odisha Panchayat Samiti Election Rules, 1991 and Odisha Gram Panchayat Election Rules, 1965 respectively ;

Whereas, Commission has decided to prepare the Electoral Roll for the concerned Zilla Parishad, Panchayat Samiti and Gram Panchayat on the basis of Assembly Electoral Roll published by Election Commission of India during January, 2015.;

Whereas, it is necessary to prepare Wardwise Electoral Rolls of Gram Panchayats as per the list of vacancies appended at Annexure-III for conduct of by-election ;

Now, therefore, the State Election Commission in exercise of powers vested in it by virtue of Article 243-K of the Constitution of India, read with relevant provisions of Odisha Zilla Parishad Act, 1991, Odisha Panchayat Samiti Act, 1959 and Odisha Gram Panchayat Act, 1964 and Rules framed thereunder directs that Wardwise Preliminary Electoral Roll of Gram Panchayats shall be prepared as per schedule detailed in Annexure-I according to the procedure prescribed in Annexure-II of this order. The final Electoral Roll of Gram Panchayat prepared under Odisha Gram Panchayat Election Rules, 1965 comprised within the Zilla Parishad Constituency, Samiti Constituency including revision or addition or alteration, if any, shall together form Electoral Roll of Zilla Parishad Constituency, Samiti Constituency.

PROCEDURE FOR PREPARATION OF THE ELECTORAL ROLL

1. The Collector as Electoral Registration Officer will be in overall charge of preparation and finalization of Electoral Roll of respective Gram Panchayat/Panchayat Samiti and Zilla Parishad.

2. Ordinarily, the Collector shall authorize the B. D. O. to function as E. R. O. in respect of the G. P. Wards, P.S. Constituencies and Z.P. Constituencies coming within his/her area. He/she may also authorize Tahasildar as E.R.O. as a stand-by measure.

3. The Electoral Roll of Assembly Constituencies prepared and published by the Election Commission of India during January, 2015 and currently in force shall be the basis for preparation of the preliminary Wardwise Electoral Rolls. For conduct of by-election to Zilla parishad Member, Electoral Roll of concerned Zilla Parishad shall be up dated. For purpose the Electrol Roll of Assembly Consituency relating to concerned Zilla Parishad have to be split into separate Electoral Roll for every Gram Panchayat under the Zilla Parishad wardwise. For conduct of by-election to Panchayat Samiti Member, Electoral Roll of concerned Panchayat Samiti shall be up dated. For the purpose the Electoral Roll of Assembly Constituency relating to concerned Panchayat Samiti have to be split into separate Electoral Roll for every Gram Panchayat under the Panchayat Samiti wardwise. For the Purpose of by-election to Sarpanch the Electoral Roll of Assembly Constituency relating to concerned Gram Panchayat and for by-election to ward Member the Electoral Roll of the Assembly Constituency relating to the concerned Wards have to be split into separate Electoral Roll for every Ward as per Rule 5(1) of O.G.P.E. Rules, 1965. The preliminary electral roll shall be prepared in Form No.1 prescribed by the Commission under the seal and signature of the Electoral Registration Officer.

4. The preliminary Electoral Roll of the Ward prepared in accordance with Rule 5(1) of O. G. P. E. Rules shall be published by the E. R. O. at a conspicuous place at the headquarters of the Gram Sasan together with a notice in Form No. 2, in accordance with the provisions under Rule 5(3). Such notice shall also be published in the Noticeboard of the concerned Panchayat Samiti/Sub-Collector and Collector. It should be ensured that the copies of the preliminary Electoral Roll is kept open at G.P. Office for inspection by the public for entire period during filing of claims and objections.

5. Only the claims of persons whose name finds place in the Assembly Electoral Roll but does not find place in the Electoral Roll of the Ward now prepared shall be entertained. No new claims for enrolment shall be entertained.

6. After completion of enquiry into all claims and objections in the manner prescribed above, the Electoral Registration Officer shall prepare the final Electoral Roll.

7. Electoral Roll of the concerned Ward, Gram Panchayat and Z.P. Constituency where by-election is proposed as per annexure-III shall only be printed. Final Electrol Roll and printed copy of the Electoral Roll shall be authenticated by E.R.O. at every page.
