### NOTIFICATION

The 23rd December, 2016

**S.R.O.No.638/2016**— Whereas, having regard to the population of the area consisting of villages in the District of Bhadrak mentioned in column (2) and (3) of the Schedule below, the density of population therein, the revenue generated for local administration, the percentage of employment in non-agricultural activities and the economic importance of the said area, it has been considered necessary to specify the said area as “transitional area”;

And, whereas, draft notification as required under the proviso to sub-section (2) of Section 4 of the Odisha Municipal Act, 1950 specifying the said area as a transitional area was issued inviting objections and suggestions, from all persons likely to be affected thereby in the notification of the Government of Odisha in the Housing & Urban Development Department No. 26733/HUD., dated the 16th November, 2016 published in the Extraordinary issue of the *Odisha Gazette* No.2072, dated the 16th November, 2016.

And, whereas, the District Magistrate, Bhadrak has intimated that no objection petitions has been received in the stipulated period of time. Besides an objection petition received in this department within the stipulated period of time has been duly considered by the State Government and found the same to be devoid of any merit.

Now, therefore, in exercise of the powers conferred by Clause (2) of Article 243 Q of the Constitution of India read with sub section (2) of Section 4 of the Odisha Municipal Act, 1950(Odisha Act, 23 of 1950), the Governor of Odisha do hereby specify the area consisting of villages mentioned in column (2) of the scheduled below with the description of boundaries as ‘transitional area’ with effect from the date on which the term of the said Gram Panchayat expires i.e. 10th March, 2017.
