No. 5519-OUHM(HFA)-5/2016/HUD.—The Government after careful consideration have been pleased to constitute a Society in the name of District Urban Housing Society (DUHS) at district level each in 30 districts and Bhubaneswar Urban Housing Society for Bhubaneswar Municipal Corporation area to be registered under Societies Registration Act-1860 to implement the Housing for All Policy, 2015. These societies shall be affiliated to Odisha Urban Housing Mission (OUHM) Society at the State level.

In case of Khurda, the area of Bhubaneswar Municipal Corporation is excluded. A separate Urban Housing Society will be constituted for the area of Bhubaneswar Municipal Corporation.
