NOTIFICATION

S.R.O. No. 336/2017— Whereas it has been brought to the notice of this Commission by the Assistant Registrar of Co-operative Societies, Bhubaneswar Circle in his Letter No. 1387, dated the 20th May, 2017 and Letter No 1820, dated the 5th July, 2017 that the election of Ekamra Multi Purpose Co-operative Society Ltd., Sundarpada (registered in OCS Act' 1962 as per Odisha Self Help Co-operatives Repeal Ordinance 2013 by the Deputy Registrar of Co-operative Societies, Puri Division in Registration No. 225/77, dated the 11th March, 2014) could not be held by the Election Officer Shri Dhananjay Chhotray, PEO for non existence of office of the Society as per report of concerned Election Officer.

And, whereas, the Secretary of Ekamra Multi Purpose Co-operative Society Ltd., Sundarpada in his Letter No. 1, dated the 17th December, 2016 and the Assistant Registrar of Co-operative Societies, Bhubaneswar Circle requested for conduct of election after existence of office was enquired by the SARCS, office of the Assistant Registrar of Co-operative Societies, Bhubaneswar Circle vide Letter No. 1251, dated the 8th May, 2017 of Assistant Registrar of Co-operative Societies, Bhubaneswar Circle.

Now, therefore, in exercise of power under section 28 AA and rule 36(2)(b) and in supersession of previous orders in this regard, it is here by directed to conduct fresh election of Ekamra Multi Purpose Co-operative Society Ltd., Sundarpada.

Shri D.V.Rao, SARCS, O/o the Assistant Registrar of Co-operative Societies, Bhubaneswar Circle is hereby appointed as new Election Officer in place of

Shri Dhananjay Chhotray, PEO for the said Society to conduct the election of a new Committee of Ekamra Multi Purpose Co-operative Society Ltd., Sundarpada following the procedures laid down in the OCS Act, 1962 & OCS (Elections to the Committees) Rules, 1992 and orders/circulars/instructions issued by the Commission from time to time fixing the date of poll, if necessary ,on **8th October, 2017**.
