In view of the urgency, pending amendment to Odisha Planning Service (Recruitment & Conditions of Service) Rules, 1996, the post of Additional Director shall be filled up by way of promotion of the Officers holding the post of Joint Director (Level-I) of Odisha Planning Service Cadre through a Departmental Promotion Committee constituted as follows:—
